 Israel Missions - A Wider Bridge helps educate North American LGBTQ leaders through in-person and virtual missions to Israel and by bringing Israeli LGBTQ leaders to North America. Mission participants are drawn from elected office, media, business, nonprofit management, and faith leadership. They experience the country's history, politics, conflict, and values as a Jewish and democratic state, and to understand the ongoing progress of the Israeli LGBTQ community and its struggles for equality. These missions also provide an opportunity for LGBTQ Americans and Israelis to find shared experience with each other.
